Nani Kumar Saikia is a science graduate from Guwahati University. After completing his graduation in the year 1991, he involved with several voluntary organizations and in the year 1997, he became the General Secretary of Sipajhar Diamond Club Community Centre (SDCCC). Being a Secretary of the club he tried to transform the football club into a developmental institution. Under his leadership SDCCC, started its Micro credit programme in the year 1998 for extending credit support to poorest of the poor for starting income generating activities. That was the beginning of Micro Finance career of Nani Kumar Saikia. With the help of Rashtriya Grammeen Vikas Nidhi (RGVN), SDCCC expanded its Micro credit activities in Darrang District and started an economic development programme in Darrang Dist. The poor who were not given credit by banks (Nationalise and Rural) they came to SDCCC and SDCCC provided credit to them. Thus economic change has started in the rural areas due to intervention of SDCCC. In the year 2003, Nani Kumar Saikia left SDCCC and in the mean time SATRA which was formed in the year 2002 invited him to becoming the Executive Director of the organization. Finally on 1st day of January 2004, he joined at SATRA as Chief Functionary.

As a Secretary of SDCCC Mr. Saikia felt need of NGOs in the rural areas for development as well as a group of dedicated and sincere youth team. So initially Mr. Saikia tried to find out a very young group and involved them with SATRA and with the help of RGVN, SATRA started Micro Finance in the last part of 2004 and train and guide the youth team.

Being a Micro Finance practitioner Mr. Saikia attended several training workshop on Micro Finance development held in different parts of India and gain firsthand knowledge on it. In the year 2009 Mr. Saikia visited Nobel laureate Dr. (Md) Yunus in Bangladesh and gained knowledge regarding their operation. Due several legal constraints Mr. Saikia decided to acquire an NBFC in the year 2011 and he is one of the promoters of the company.
